

CONTRACT AGREEMENT

THIS AGREEMENT made this DEC 08 2019 day of between **Philippine Navy, Armed Forces of the Philippines** (hereinafter called "the entity") of the one part and **CHRISTIAN FAITH TRADING, 4-G-5, VFL Subd., San Rafael II, Noveleta Cavite** (herein after called "the Contractor/Supplier") of the other part:

WHEREAS the entry is desirous that the Contractor execute the Procurement of **Delivery of Supplies and Materials for the Conduct of Basic Seaman Courses at NETDC CY-2019 (GS-PNBAC2-2019-36) within Thirty (30) Calendar Days from Receipt of the Contractor of the Notice To Proceed** under Project PN BAC Resolution No. 187-19 (herein after called the "Delivery of Supplies and Materials for the Conduct of Basic Seaman Courses at NETDC CY-2019 ") and the entity has accepted the Bid for **Two Million Seven Hundred Seventeen Thousand Four Hundred Fifty Eight Pesos and 00/100 Centavos (Php 2,717,458.00)** only by the contractor for the execution and completion of such **Delivery of Supplies and Materials for the Conduct of Basic Seaman Courses at NETDC CY-2019** therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - a) General Conditions of Contract;
 - b) Special Conditions of Contract;
 - c) Specifications;
 - d) Supplemental/Bid Bulletin (If any);
 - e) Invitation to Apply for Eligibility and to Bid;
 - f) Bidding Documents;
 - g) Bid Form;
 - h) Eligibility Requirements;
 - i) Performance Security;
 - j) Notice of Award of Contract and the Bidder's conformed thereto;
 - k) Other contract documents that may be required by existing laws and/or the entity.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the **Delivery of Supplies and Materials for the Conduct of Basic Seaman Courses at NETDC CY-2019** therein in conformity with the provisions of this Contract in all aspects.
4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the **Delivery of Supplies and Materials for the Conduct of Basic Seaman Courses at NETDC CY-2019** and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by the Contract.
