
partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

3. A complete set of Bidding Documents will be provided by PNBAC Secretariat to the interested Bidders upon payment of a non-refundable fee in the amount indicated above at CRB, CPMU, Philippine Navy Finance Center (PNFC), Naval Station Jose Francisco, Fort Bonifacio, Taguig City.
4. All interested bidders shall accomplish the Sales of Bidding Document form issued by the PNBAC Secretariat prior payment of the Price of Bidding Documents.
5. The BAC shall draw up the short list of consultants from those who have submitted Expression of Interest and eligibility documents, and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act", and its Implementing Rules and Regulations (IRR). Only the top three (3) firms will be invited to submit their technical and financial proposal.
6. A Notice of Eligibility and Shortlisting indicating therein the schedule for the submission of Technical and Financial Documents shall be issued.
7. Proposals shall be evaluated using the **Quality-Cost Based Evaluation/Selection (QCBE/S)**. The Consultant achieving the Highest Technical Score has its Financial Proposal opened and provided that it is within the ABC or cost estimate is invited to negotiate a contract.
8. The project must be completed within Two Hundred Forty (240) calendar days after receipt of the Notice to Proceed, inclusive of mobilization Period.
9. The Philippine Navy reserves the right to accept or reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award, in accordance with Section 41 of RA 9184 and its Revised IRR, without thereby incurring any liability to the affected bidder or bidders.
