Section I. Invitation to Bid

1. The Armed Forces of the Philippines (Philippine Navy), through the Philippine Navy Appropriations CY 2020 intends to apply the sum of **Eight Million Pesos (Php 8,000,000.00)** being the ABC to payments under the contract for **Continuous Maintenance Availability of BRP ANG PANGULO (ACS25) (MR-PNBAC1-2020-40)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Armed Forces of the Philippines (Philippine Navy) through the Philippine Navy Bids and Awards Committee (PNBAC-1) now invites bids for the above Procurement Project. Delivery of the Goods is required by **within sixty (60) calendar days upon receipt of Notice to Proceed (NTP)**. Bidders should have completed, within **the last five (5) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184. **Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.**
4. Prospective Bidders may obtain further information from Philippine Navy Bids and Awards Committee (PNBAC-1) and inspect the Bidding Documents at the address given below during **8:00 AM to 5:00 PM, Monday to Friday**
5. A complete set of Bidding Documents may be acquired by interested Bidders on **October 09 to October 27, 2020 from 8:00 AM to 5:00 PM, Monday to Friday** from the given address and website below upon payment of a non-refundable fee in the amount **Ten Thousand Pesos (Php 10,000.00)** at **CRB, CPMU, Philippine Navy Finance Center (PNFC), Naval Station Jose Francisco, Fort Bonifacio, Taguig City**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person or through electronic means.



7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before **October 27, 2020, 09:00 AM, Tuesday**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **October 27, 2020, 09:00 AM, Tuesday** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The Armed Forces of the Philippines (Philippine Navy) reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
