

Contract Agreement

THIS AGREEMENT made this 18 DEC 2020 between **Philippine Navy, Armed Forces of the Philippines**, (hereinafter called "the entity") of the one part and **ZYVIMEX ENTERPRISES** at 20 Orange St., N. Springfield, Molino 3, Bacoor, Cavite (hereinafter called "the Supplier") of the other part

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., for the **Supply and Delivery of Drugs and Medicines for Pharmaceutical Services of MNH within Forty Five (45) Calendar Days** from Receipt of the Supplier of the **Notice To Proceed** under Project Nr: GS-PNBAC2-2020-33 and has accepted a Bid by the Supplier for the supply of those Supplies and Materials in the sum of **Four Million Two Hundred Five Thousand Three Hundred Sixty Two Pesos and 30/100 (Php 4,205,362.30)** only. (hereafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- (g) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
- (h) Eligibility requirements, documents and/or statements;
- (i) Performance Security;
- (j) Credit line issued by a licensed bank, if any;
- (k) Notice of Award of Contract and the Bidder's conforme thereto;
- (l) Other contract documents that may be required by existing laws and/or the Entity.


