THIS AGREEMENT, made this _____ between **Philippine Navy, Armed Forces of the Philippines** (hereinafter called the "Entity") of the one part and **Scan Marine, Inc.** (hereinafter called the "Contractor") of the other part:

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz., for the project **Procurement and Installation of WCEIS for PC374, PC376, PC377, PC387, PC389 and YT225 Lot 2 – Procurement and Installation of COMMELEX Equipment for PC374, PC376, PC377, PC387, PC389 and YT225** and has accepted a Bid by the supplier for the supply of those goods and services in the sum amount of **Twenty One Million Four Hundred Ninety Nine Thousand Seven Hundred Ninety Eight Pesos (PhP21,499,798.00) only** (hereinafter called "the Contract Price")


