(302CO-GSM-103-20)**

THIS AGREEMENT, made this _____ between **Philippine Navy, Armed Forces of the Philippines** (hereinafter called the "Entity") of the one part and **Abemasu Marine Parts & Ship Repair Contractor** (hereinafter called the "Contractor") of the other part:

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz., for the project **Supply of Materials/Parts for the PMS and COBS of PHILFLT Vessels (PIELSTICK Engines)** and has accepted a Bid by the supplier for the supply of those goods and services in the sum amount of **Three Million Three Hundred Eighty Three Thousand Pesos (PhP3,383,000.00) only** (hereinafter called "the Contract Price")
