(302CO-GSM-097-20)**

THIS AGREEMENT, made this _____ between **Philippine Navy, Armed Forces of the Philippines** (hereinafter called the "Entity") of the one part and **Anwelh Holdings Inc.** (hereinafter called the "Contractor") of the other part:

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz., for the project **Supply of Materials/Parts for the PMS and RAS of NAVSOG Units (Sponson)** and has accepted a Bid by the supplier for the supply of those goods and services in the sum amount of **Thirteen Million Eight Hundred Eighty Five Thousand Four Hundred Forty Four Pesos and 77/100 (PhP13,885,444.77) only** (hereinafter called "the Contract Price")


