The Command looks forward to your support and full cooperation in the accomplishment of this project.



THIS AGREEMENT made this **03 JUN 2021** between **Philippine Navy, Armed Forces of the Philippines** (hereinafter called "the entity") of the one part and **EABP DRILLING & CONSTRUCTION** at 215 St. Peter St., Barangay Holy Spirit, Quezon City (Hereinafter called "the Supplier") of the other part

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., for **Consulting Services for the Conduct of Soil Investigation Works for the Various PN Units for the Relocation at Naval Station Leovigildo Gantioqui (NSLG), San Antonio, Zambales** within **Ninety (90) Calendar Days** from Receipt of the Contractor of the **Notice to Proceed** under Project Nr: CS-PNBAC2-2020-03 and has accepted a Bid by the Supplier for the supply of those Supplies and Materials in the sum of **Three Million Two Hundred Ninety Thousand Five Hundred Sixty Pesos (PhP 3,290,560.00)** only. 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.


2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:

- (g) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
- (h) Eligibility requirements, documents and/or statements;
- (i) Performance Security;
- (j) Credit line issued by a licensed bank, if any;
- (k) Notice of Award of Contract and the Bidder's conforme thereto;
- (l) Other contract documents that may be required by existing laws and/or the Entity.

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.

4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.




