THIS AGREEMENT, made this APR 20 2021 between Philippine Navy, Armed Forces of the Philippines (hereinafter called the "Entity") of the one part and **Colorado Shipyard Corporation** (Hereinafter called the "Contractor") of the other part:

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz., for the project of **Beaching and Other Related Repairs (BORR) of Patrol Boat 359 (PB359)** and has accepted a Bid by the supplier for the supply of those goods and services in the sum amount of **Three Million Four Hundred Eighty Six Thousand Pesos (Php3,486,000.00) Only** (hereinafter called "the Contract Price")


