(302CO-GSM-035-21)**

THIS AGREEMENT, made this JUL 21 2021 between Philippine Navy, Armed Forces of the Philippines (hereinafter called the "Entity") of the one part and **Scan Marine Incorporated** (hereinafter called the "Contractor") of the other part:

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz., for the project of **Supply and Delivery of Materials for Enhancement of Communications Equipment (C4ISR-PNBAC1-2021-19)** and has accepted a Bid by the supplier for the supply of those goods and services in the sum amount of **Two Million Nine Hundred Thirty Thousand Nine Hundred Pesos (Php 2,930,900.00)** (hereinafter called "the Contract Price")


