



THIS AGREEMENT, made this \_\_\_\_\_ between **Philippine Navy, Armed Forces of the Philippines** (hereinafter called the "Entity") of the one part and **Dynacast Shipbuilding & Repairs Inc.** (hereinafter called the "Contractor") of the other part:

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz., for the project **Drydocking and Other Related Repairs of BRP FILIPINO FLOJO (PC386)** and has accepted a Bid by the supplier for the supply of those goods and services in the sum amount of **TWENTY ONE MILLION FOUR HUNDRED FORTY EIGHT THOUSAND SIX HUNDRED TEN PESOS (P21,448,610.00)** only (hereinafter called "the Contract Price")

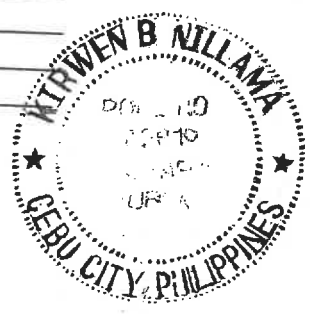
