

The PN looks forward to your support and full cooperation in the accomplishment of this project.



THIS AGREEMENT, made this DEC 29 2020 between **Philippine Navy, Armed Forces of the Philippines** (hereinafter called the "Entity") of the one part and **Josefa slipways Incorporated** (hereinafter called the "Contractor") of the other part:

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz., for the project **Continuous Maintenance availability of LCU-ROK** and has accepted a Bid by the supplier for the supply of those goods and services in the sum amount of **Sevan Million Nine Hundred Seventy Five thousand Four Hundred Ninety One Pesos and 88/100 (P7,975,491.88)** only (hereinafter called "the Contract Price")

The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this contract
