


**Contract Agreement
(302CO-GSM-136-2020)**

THIS AGREEMENT, made this _____ between Philippine Navy, Armed Forces of the Philippines (hereinafter called the "Entity") of the one part and **88 Electronics Supply** (hereinafter called the "Contractor") of the other part:

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz., for the project of **Supply of Materials for the Repair and Maintenance of Downlink Transmitter/Receiver of Aw109e Helicopters** and has accepted a Bid by the supplier for the supply of those goods and services in the sum amount of **Eight Million Nineteen Thousand Pesos (Php 8,019,000.00)** (hereinafter called "the Contract Price")

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.




