PNBAC2 RESOLUTION No. 131-2021

Resolution Declaring SOUTHCOAST MARKETING INC. as the Winning Bidder for the project "Supply and Delivery of Materials for the Enhancement of NAW Supply Bodega" and Recommending Approval of the NOA

WHEREAS, the Philippine Navy thru the Philippine Navy Bids and Awards Committee2 caused the advertisement of the Invitation to Bid (ITB) for the project "**Supply and Delivery of Materials for the Enhancement of NAW Supply Bodega**" at the Philippine Government Electronic Procurement System Website (PhilGEPS) and Philippine Navy Website on 17 November 2021. Likewise, it was posted at conspicuous places within the premises of the PNBAC Office continuously for seven (7) calendar days;

WHEREAS, the PNBAC2 conducted public bidding on 090900H December 2021 through Video Conferencing (VTC) wherein three (3) bidders submitted the required Eligibility, Technical and Financial Proposals of the bid. One (1) bidder, **SOUTHCOAST MARKETING INC.** was rated "**PASSED**" and subsequently declared as "**eligible**" bidder while **MLTP ENTERPRISES** was rated "**FAILED**" for non-compliant under **Section VIII. Checklist of Technical and Financial Documents under Tab F**, failure to attached supporting document for Single Largest Completed Contract (SLCC) particularly Technical Inspection and Acceptance Committee (TIAC) Report and **PHILIPPINE VISION GROUP (PVG) INC.** was rated "**FAILED**" for non-compliant under **Section VIII. Checklist of Technical and Financial Documents under Tab F**, failure to attached the correct document for Single Largest Completed Contract (SLCC) ;

WHEREAS, after a detailed evaluation of the financial proposals submitted by the eligible bidder, **SOUTHCOAST MARKETING INC.**, the PNBAC2 found the proposals compliant as to form and within the ABC of the project, thus, it was declared the "**Single Calculated Bid**" subject to post qualification, to wit:

WHEREAS, the Post Qualification Team headed by **CAPT PERCEEVAL O BUTED PN(GSC)** conducted post qualification inspection via Video Conferencing (VTC) to **SOUTHCOAST MARKETING INC.** on **13 December 2021** at 1246-C F. Torres St., Sta. Ana, Manila and subsequently submitted said inspection report to Chairman, PNBAC thru the Head Secretariat on **16 December 2021**. After thorough verification, validation and ascertaining all

the statements made and documents submitted by the bidder, the Post Qualification Team found and established the bid to be **“Responsive”** to the requirements of the project;
