**PNBAC2 RESOLUTION No. 147-2021**

**Resolution Declaring PHILIPPINE VISION GROUP (PVG) INC. as the Winning Bidder for the project “Replacement of Dilapidated Tent Collapsible for use of PN Units” and Recommending Approval of the NOA**

**WHEREAS**, the Philippine Navy Bids and Awards Committee2 conducted procurement of “Replacement of Dilapidated Tent Collapsible for use of PN Units” through “Negotiated Procurement” with an Approved Budget for the Contract of **Five Million Five Hundred Forty Thousand Four Hundred Pesos (Php 5,540,400.00)** only;

**WHEREAS**, the Philippine Navy Bids and Awards Committee2 invited three (3) known capable proponent/contractor however only one (1) participated in this project, **PHILIPPINE VISION GROUP (PVG) INC.** relative to the procurement of said project;

**WHEREAS**, **PHILIPPINE VISION GROUP (PVG) INC.** submitted a proposal for the project on **160900H December 2021** including its eligibility and technical requirements;

**WHEREAS**, after perusal of the proponent's submitted documents, the PNBAC2 found it all to be compliant with the eligibility and technical requirements as required by RA 9184 and declared it as “**PASSED**” and subsequently declared as “**eligible**” bidder. Furthermore, after examining its financial component and its bid offer, to wit:

Loyola Heights, Quezon City, Metro Manila to determine the proponent's compliance and responsiveness to the requirements of the project;

**WHEREAS**, after careful verification, validation and ascertainment of the genuineness and accuracy of the legal, technical and financial documents submitted, the PNBAC2 found **PHILIPPINE VISION GROUP (PVG) INC.** “**Responsive**” to all the requirements of the project;

**NOW, THEREFORE**, for and in consideration of the foregoing, **We**, the **Members of the Philippine Navy Bids and Awards Committee2**, by virtue of the powers vested on **Us** by law, hereby **RESOLVE** as it is hereby **RESOLVED** the following:
