**PNBAC1 RESOLUTION No. 027-2022**

**Resolution Declaring LIAHONA GOLD GENERAL MERCHANDISE as the Winning Bidder for the project "Supply and Delivery of Training Requirements of Naval Command Courses for CY 2022" and Recommending Approval of the NOA**

**WHEREAS**, the Philippine Navy Bids and Awards Committee2 conducted procurement of "Supply and Delivery of Training Requirements of Naval Command Courses for CY 2022" through "Negotiated Procurement" with an Approved Budget for the Contract of **One Million One Hundred Thirteen Thousand Six Hundred Sixty Six Pesos 50/100 (Php 1,113,666.50)** only;

**WHEREAS**, the Philippine Navy Bids and Awards Committee2 invited three (3) known capable proponent/contractor however only one (1) participated in this project, **JV OF LIAHONA GOLD GENERAL MERCHANDISE** relative to the procurement of said project;

**WHEREAS**, during the scheduled **Submission and Opening of Bids Envelope** on 230900H March 2022, **LIAHONA GOLD GENERAL MERCHANDISE** submitted a proposal for the project including its eligibility and technical requirements.

**WHEREAS**, after perusal of the proponent's submitted documents, the PNBAC2 found it to be compliant with the eligibility and technical requirements as required by RA 9184 and declared it as "**PASSED**";

**WHEREAS**, a series of negotiations on the provisions of the Contract to be adopted including the price, the PNBAC2 and **LIAHONA GOLD GENERAL MERCHANDISE** agreed on the stipulations and the amount of **One Million Seventy Four Thousand One Hundred Twenty Five Pesos (Php 1,074,125.00)** only as the Contract price;

**WHEREAS**, as required by law, a **Post-Qualification Inspection** was conducted on **24 March 2022** headed by **CDR SAMMY E PACUA PN** at 610 R Basa St., Cavite City, Cavite to determine the proponent's compliance and responsiveness to the requirements of the project;

**WHEREAS**, after careful verification, validation and ascertainment of the genuineness and accuracy of the legal, technical and financial documents submitted, the PNBAC2 found **LIAHONA GOLD GENERAL MERCHANDISE "Responsive"** to all the requirements of the project;

**NOW, THEREFORE**, for and in consideration of the foregoing, **We**, the **Members of the Philippine Navy Bids and Awards Committee2**, by virtue of the powers vested on **Us** by law, hereby **RESOLVE** as it is hereby **RESOLVED** the following:

a. To declare the bid of **LIAHONA GOLD GENERAL MERCHANDISE** as the **Single Calculated Responsive Bid** for the project "Supply and Delivery of Training Requirements of Naval Command Courses for CY 2022".
