**PNBAC1 RESOLUTION No. 030-2022**

**Resolution Declaring JV OF PROPMECH CORPORATION AND SAFEHULL MARINE TECHNOLOGIES, INCORPORATED as the Winning Bidder for the project “Beaching and Other Related Repair of BA489” and Recommending Approval of the NOA**

**WHEREAS**, the Philippine Navy thru the Philippine Navy Bids and Awards Committee1 caused the advertisement of the Invitation to Bid (ITB) for the project “**Beaching and Other Related Repair of BA489**” at the Philippine Government Electronic Procurement System Website (PhilGEPS) and Philippine Navy Website last 17 December 2021. Likewise, it was posted at conspicuous places within the premises of the PNBAC Office continuously for seven (7) calendar days;

**WHEREAS**, the PNBAC1 conducted public bidding on 030900H March 2022 through Video Teleconferencing (VTC) wherein one (1) bidder, **JV OF PROPMECH CORPORATION AND SAFEHULL MARINE TECHNOLOGIES, INCORPORATED** submitted the required Eligibility, Technical and Financial Proposals of the bid. All documents were found to be compliant and rated “**PASSED**” and subsequently declared as “**eligible**” bidder;
