**PNBAC1 RESOLUTION No. 016-2022**

**Resolution Declaring SCAN MARINE INC. the Second Lowest Calculated Bidder as the Winning Bidder for the project "Procurement and Installation of NAVSENS Equipment for LS550, LC299, LC298 and LC297 (LOT 1)" and Recommending Approval of the NOA**

**WHEREAS**, the Philippine Navy thru the Philippine Navy Bids and Awards Committee1 caused the advertisement of the Invitation to Bid (ITB) for the project "**Procurement and Installation of NAVSENS Equipment for LS550, LC299, LC298 and LC297 (LOT 1)**" at the Philippine Government Electronic Procurement System Website (PhilGEPS) and Philippine Navy Website last 20 January 2022. Likewise, it was posted at conspicuous places within the premises of the PNBAC Office continuously for seven (7) calendar days;

**WHEREAS**, the PNBAC1 conducted public bidding on 080900H February 2022 through Video Teleconferencing (VTC) wherein two (2) bidders submitted the required Eligibility, Technical and Financial Proposals of the bid. Both were rated "**PASSED**" and subsequently declared as "**eligible**" bidders;

**WHEREAS**, after a detailed evaluation of the financial proposals submitted by the eligible bidders, the PNBAC1 found both the proposals compliant as to form and within the ABC of the project. Furthermore, the proposal of **IONE RESOURCES INC.** was calculated to be the lowest, thus, it was declared the "**Lowest Calculated Bid**" subject to post qualification, to wit:

**WHEREAS**, the Post Qualification Team headed by **CDR DYNASTY B CHUA PN(GSC)** conducted post qualification inspection to **IONE RESOURCES INC.** on **11 February 2022** at 1006 Centerpoint Bldg., Julia Vargas Ave., Cor. Garnet Road, Ortigas Center, Pasig City and subsequently submitted said inspection report to the Chairman, PNBAC thru the Head Secretariat on **04 March 2022**.

**WHEREAS**, After thorough verification, validation and ascertaining all the statements made and documents submitted by the bidder, the Post Qualification Team found and established the bid to be "**Non-Responsive**" for non-compliant to the requirements contained in the Bidding Documents as prescribed by RA 9184 specifically the proof of completion of its SLCC identified as Supply and Delivery of Naval Equipment with an amount of Php 57,256,482.00

which is not sufficient to satisfy the requirements for this project and similar contract shall include Installation of NAVSENS Equipment.

**WHEREAS**, the Post Qualification Team headed by **CDR FREDERICK M FRANCISCO PN** conducted post qualification inspection to **SCAN MARINE INC.** on **29 March 2022** at 160 Honorio Lopez Blvd., Balut, Tondo, Manila and subsequently submitted said inspection report to the Chairman, PNBAC thru the Head Secretariat on **05 April 2022**. After thorough verification, validation and ascertaining all the statements made and documents submitted by the bidder, the Post Qualification Team found and established the bid to be **“Responsive”** to the requirements of the project;

**NOW, THEREFORE**, for and in consideration of the foregoing, **We**, the **Members of the Philippine Navy Bids and Awards Committee<sup>1</sup>**, by virtue of the powers vested on **Us** by law, hereby **RESOLVE** as it is hereby **RESOLVED** the following:

a. To declare the bid of **SCAN MARINE INC.** as the **Second Calculated Responsive Bid** for the project **“Procurement and Installation of NAVSENS Equipment for LS550, LC299, LC298 and LC297 (LOT 1)”**.

b. To recommend for the Approval of the **Flag Officer In Command, Philippine Navy** of the corresponding **Notice of Award**.
