
Dear Mr. Fayloga:

**PNBAC1 RESOLUTION No. 053-2022**

**Resolution Declaring HB COMMUNICATIONS TRADING INC. as the winning Supplier for the project "Procurement and Installation of Multi Band Base Radio of PS39" and Recommending Approval of the NOA**

**WHEREAS**, the Philippine Navy Bids and Awards Committee1 conducted procurement of "Procurement and Installation of Multi Band Base Radio of PS39" through "Direct Contracting" with an Approved Budget for the Contract of **Eight Million Nine Hundred Thirty Seven Thousand Five Hundred Pesos (Php 8,937,500.00)** only;

**WHEREAS**, the Philippine Navy Bids and Awards Committee1 formally sent a Letter of Invitation to **HB COMMUNICATIONS TRADING INC.** on **18 April 2022** relative to the procurement of said project;

**WHEREAS**, **HB COMMUNICATIONS TRADING INC.** submitted a proposal for the project on **050900H May 2022** including its eligibility and technical requirements;
