PNBAC2 RESOLUTION No. 052-2022

Resolution Declaring NV BALBUENA CONSTRUCTION as the Winning Bidder for the project "Supply and Delivery of Labor and Materials for the Modification of RTHO to NPMC Temporary Offices" and Recommending Approval of the NOA

WHEREAS, the Philippine Navy thru the Philippine Navy Bids and Awards Committee2 caused the advertisement of the Invitation to Bid (ITB) for the project "**Supply and Delivery of Labor and Materials for the Modification of RTHO to NPMC Temporary Offices**" at the Philippine Government Electronic Procurement System Website (PhilGEPS) and Philippine Navy Website on 27 May 2022. Likewise, it was posted at conspicuous places within the premises of the PNBAC Office continuously for seven (7) calendar days;

WHEREAS, the PNBAC2 conducted public bidding on 280900H June 2022 through Video Conferencing (VTC) wherein one (1) bidder, **NV BALBUENA CONSTRUCTION** submitted the required Eligibility, Technical and Financial Proposals of the bid. All documents were found to be compliant and rated "**PASSED**" and the bidder was declared eligible to bid subject to post qualification;


