

THIS AGREEMENT made this _____ between Philippine Navy, Armed Forces of the Philippines (hereinafter called "the entity") of the one part and LVRO Construction and Supply of 11172 Maharika National Highway, Barangay Rizal, Surigao City, Surigao Del Norte Caraga (hereinafter called "the Contractor") of the other part.

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., for the project Supply of Labor and Materials for the Repair & Maintenance of Access Road Along NBRR Perimeter Fence (Phase 7) (INFRA-PNBAC2-2022-01) and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of One Million Nine Hundred Eighty-Four Thousand Three Hundred Four Pesos and 34/100 (P 1,984,304.34) only (hereinafter called the "Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

2. The following documents shall be attached, deemed to form and be read and construed as part of this Agreement, viz.,

- (a) Condition of contract
- (b) Drawing plans, if applicable
- (c) Specification, if applicable
- (d) Invitation to apply for eligibility and to bid
- (e) Bidding documents
- (f) Addenda and/or supplemental/bid bulletins, if any
- (g) Bid form including all the documents/statements contained in the winning bidder's two bidding envelopes, as annexes.
- (h) Eligibility requirements, documents and/ or statements
- (i) Performance security
- (j) Credit line issued by a licensed bank in accordance with the provision of this IRR-A, if applicable.
- (k) Notice of Award of contract and winning bidder's "conformer" thereto, and
- (l) Other contract documents that may be required by existing laws and/ or the procuring entity concerned

3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works. Remedy any defects therein in conformity with the provision of this Contract in all respects.

4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum may become payable under the provisions of this Contract at the times and in the manner prescribed by the contract.
