

**CONTRACT AGREEMENT
PROCUREMENT OF RUBBER BOATS WITH OUTBOARD MOTOR
FOR NIF-WEST
(GS-PNBAC2-2022-60)**

THIS AGREEMENT, made this _____ day of _____, 2022 between **ARMED FORCES OF THE PHILIPPINES (AFP)**, Camp General Emilio Aguinaldo, Quezon City, hereinafter called the "Entity" of the one part through the **Naval Installation Facilities West (NIF-WEST)** as represented by the Flag Officer-In-Command, Philippine Navy, **VADM ADELUIS S BORDADO PN**; with office address at *Naval Station Jose Andrada, 2335 Roxas Boulevard, Manila* and **SCAN MARINE INC.** represented by its Authorized Representative, **Mr. Roland A. Maghanoy**, a private organization and existing under the laws of the Republic of the Philippines with business address *160 Honorio Lopez Boulevard Balut, Tondo, Manila* hereinafter called the "Supplier" of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Procurement of Rubber Boat with Outboard Motor NIF-WEST Project** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of *Fifteen Million Two Hundred Ninety-Nine Thousand Nine Hundred Pesos (P15,299,900.00)* hereinafter called "the Contract Price".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:

- a. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract;
 - iv. Supplemental or Bid Bulletins, if any;
- b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted, including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
