PMCBAC RESOLUTION No. 44-2022

**Resolution declaring Buennelyn General Merchandise as the Winning Bidder for the project "Procurement of Individual Clothing Requirements of Pre-Entry Students of PMC, Lot 3- Assorted ICA" with an ABC of Php3,316,112.50" and Recommending for Approval of the NOA**

WHEREAS, the Philippine Marine Corps thru the Philippine Marine Corps Bids and Awards Committee caused the advertisement of the Invitation to Bid (ITB) for the project "Procurement of Individual Clothing Requirements of Pre-Entry Students of PMC, Lot 1- PBDU" at the Philippine Government Electronic Procurement System (PhilGEPS) website on **03 September 2022**. Likewise, it was posted at conspicuous places within the premises of the PMCBAC Office continuously for seven (7) calendar days;

WHEREAS, the PMCBAC conducted public bidding on 220900H September 2022 at PMCBAC Conference Room, SMART House, Marine Barracks Rudiardo Brown, Fort Bonifacio, Taguig City wherein (2) bidders submitted the required Eligibility, Technical and Financial Proposals of the bid. All were rated "passed" and subsequently declared as "eligible" bidders;
