8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be conducted via **blended/VTC on May 17, 2024 09:00 A.M (Friday)** at **Philippine Navy Bids and Awards Committee, Naval Station Jose Francisco, Fort Bonifacio, Taguig City**.
