

**CONTRACT AGREEMENT
(302CO-SVCS-167-23)**

THIS AGREEMENT made this _____ between Philippine Navy, Armed Forces of the Philippines (hereinafter called "the Entity") of the one part and JV of Primetech Aero Defence and Logistics Inc. & BT Industries Incorporated of 8 Mark St. Metrogate Complex, Brgy. WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly Supply and Delivery of Spare Parts, Supplies and Services for SMI/ARAS of NH440 & NH441: Lot - 4 ARAS NH441) and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of FIFTY-FOUR MILLION NINE HUNDRED EIGHTY-EIGHT THOUSAND SEVEN HUNDRED EIGHTY-FOUR PESOS (PhP54,988,784.00) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

4. The **Philippine Navy, Armed Forces of the Philippines** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
