

CONTRACT AGREEMENT

(304thCO-GSM-05-23)

THIS AGREEMENT made this ___ day of _____ between **Philippine Navy, Armed Forces of the Philippines** (hereinafter called "the entity") of the one part and **iSource Asia Business Solution Corporation**, 497-B Imelda Bldg. Calbayog St., Brgy Highway Hills Mandaluyong City, Metro Manila (herein after called "the Contractor/Supplier") of the other part:

WHEREAS the entry is desirous that the Contractor execute the Procurement of "Supply and Delivery for the Acquisition of Printing and Publication Equipment of TDC, NETDC (GS-PNBAC2-2023-53)" within Thirty (30) Calendar Days from Receipt of the Contractor of the Notice To Proceed under Project PNBAC2 Resolution No. 057-2023, herein after called the "Supply and Delivery for the Acquisition of Printing and Publication Equipment of TDC, NETDC (GS-PNBAC2-2023-53)" and the entity has accepted the Bid for ONE MILLION ONE HUNDRED NINETY-EIGHT THOUSAND PESOS (PhP1,198,000.00) only by the contractor for the execution and completion of such Supply and Delivery for the Acquisition of Printing and Publication Equipment of TDC, NETDC therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - a) General Conditions of Contract;
 - b) Special Conditions of Contract;
 - c) Specifications;
 - d) Supplemental/Bid Bulletin (If any);
 - e) Invitation to Apply for Eligibility and to Bid;
 - f) Bidding Documents;
 - g) Bid Form;
 - h) Eligibility Requirements;
 - i) Performance Security;
 - j) Notice of Award of Contract and the Bidder's conformed thereto;
 - k) Other contract documents that may be required by existing laws and/or the entity.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Procurement of **Supply and Delivery for the Acquisition of Printing and Publication Equipment of TDC, NETDC** therein in conformity with the provisions of this Contract in all aspects.
4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Procurement **Supply and Delivery for the Acquisition of Printing and Publication Equipment of TDC, NETDC** and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by the Contract.


