

CONTRACT AGREEMENT
Supply and Delivery of Labor and Materials for the Enhancement of NSAJ
Multi-Purpose Hall (INFRA-PNBAC2-2023-14)

THIS AGREEMENT, made this _____ day of MAR 25 2024, 2024 between **ARMED FORCES OF THE PHILIPPINES (AFP)**, Camp General Emilio Aguinaldo, Quezon City, hereinafter called the "Entity" of the one part through the **Naval Installation Facilities West (NIF-WEST)** as represented by the Commanding Officer, Philippine Navy Procurement Center **CAPT ARCHIBALD DINO C DELFIN PN (MNSA)**; with office address at *Naval Station Jose Francisco, Fort Bonifacio, Taguig City* and **C-BROS CONSTRUCTION** represented by its Owner/General Manager, **Mr. Vicente B. Cuyop**, a private organization and existing under the laws of the Republic of the Philippines with business address *Andres Bonifacio, Diffun Quirino* hereinafter called the "Contractor" of the other part;

WHEREAS, the Entity is desirous that the Contractor **Supply and Delivery of Labor and Materials for the Enhancement of NSAJ Multi-Purpose Hall (INFRA-PNBAC2-2023-14)** hereinafter called "the Works" and the Entity has accepted the Bid for **THREE MILLION NINE HUNDRED ELEVEN THOUSAND SEVEN HUNDRED TWELVE PESOS AND 59/100 (P3,911,712.59)** only by the Contractor for the execution and completion of such Works and the remedying of any defects therein.


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Drawings/Plans;
 - ii. Specifications
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any;
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted, including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;


 - c. Performance Security;
 - d. Notice of Award of Contract and the Bidder's conforme thereto; and
 - e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
