Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens; pursuant to RA no. 5183 and subject to R.A. 9290 otherwise known as "The Footwear, Leather Goods and Tannery Industries Development Act".
4. Prospective Bidders may obtain further information from Philippine Marine Corps Bids and Awards Committee (PMCBAC) and inspect the Bidding Documents at the address given below during, **Monday to Friday from 8:00 AM to 5:00 PM**.

A complete set of Bidding Documents may be acquired by interested Bidders on **April 18, 2024 to May 08, 2024 from 8:00 AM to 5:00 PM, Monday to Friday and until May 09, 2024 of 09:00 AM** from the given address and website below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Twenty-Five Thousand Pesos (PhP25,000.00) for lot 1 and Ten Thousand Pesos (PhP10,000.00) for Lot 2**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person or through electronic means.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be conducted via **blended/VTC on May 09, 2024, 09:00 AM, Thursday at SMART House, PMCBAC Office, Marine Barracks Rudiardo Brown, Fort Bonifacio, Taguig City**. Bidders **may physically attend** the opening and evaluation of bidding documents or through **VTC via Zoom application**. Meeting I.D: **260 106 2021** and Passcode: **162021** who choose to attend the activity. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

The Philippine Marine Corps reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
