

**CONTRACT AGREEMENT
(302CO-GSM-048-23)**

THIS AGREEMENT made this _____ between Philippine Navy, Armed Forces of the Philippines (hereinafter called "the Entity") of the one part and HINO MOTORS PHILIPPINES CORPORATION of Industrial Park Road, Canlubang Industrial Estate, Calamba Laguna (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly Supply and Delivery of 4th Year PN Vehicle Re-Fleeting Program Lot 5 Mini-Bus (Manual) 3 Units and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of THIRTEEN MILLION FOUR HUNDRED FORTY THOUSAND PESOS (PhP13,440,000.00) (hereinafter called "the Contract Price").

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

4. The **Philippine Navy, Armed Forces of the Philippines** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


