THIS AGREEMENT made this _____ between **Philippine Marine Corps, Philippine Navy, Armed Forces of the Philippines** (hereinafter called "the entity") of the one part and **Forman Construction Services** at 67 A. Roque Street, Tonsuya, Malabon City (Hereinafter called "the Contractor") of the other part:

WHEREAS, the Entity is desirous that the contractor execute the project, **Construction of One (1) Storey Two (2) Classroom Building within One Hundred Eighty (180) Calendar Days** upon issuance of **Site Possession Project Nr: INFRA-PMCBAC-2023-01** and has accepted a bid by the contractor for the execution and completion of works in the sum of **Two Million Eight Hundred Thirty-Five Thousand Pesos (Php2,835,000.00)** only. (hereafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:

- (a) Notice of Award of Contract and the Bidder's conforme thereto;
- (b) PMCBAC Resolution
- (c) Post Qualification Inspection Report
- (d) Minutes of Submission and Opening of Bids Envelopes (SOBE)
- (e) Abstract of Bids
- (f) Eligibility and Technical Information
- (g) Financial Information
- (h) Invitation to Bid & other Bidding Documents
- (i) Minutes of Pre-Bid Conference
- (j) Certificate of Funding Chargeability
- (k) Other contract documents that may be required by existing laws and/or the Entity.

3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the project and to remedy defects therein in conformity in all respects with the provisions of the Contract.

4. In consideration of the execution and completion of the project by the contractor, the entity hereby covenants to pay the contractor. The unit prices in the contractor's calculated bid, as applied to the actual quantities accomplished as certified by the entity under the provisions of this contract, at the times and in the manner prescribed by this contract agreement.
