

Contract Agreement
(PNPC-PB-GSM-11-009-23-NIF-NCR)

THIS AGREEMENT made this JAN 30 2024 between **Philippine Navy, Armed Forces of the Philippines** (hereinafter called "the entity") of the one part and **Everyday Enterprise** at Angus Complex Bldg., Brgy, Matina Crossing Davao City (Hereinafter called "the Supplier") of the other part:

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz., for the project, **Supply and Delivery of Medical Equipment for use of MNH** within **Sixty (60) Calendar Days** upon Receipt of the Supplier of the **Notice To Proceed** under Project Nr: **GS-PNBAC2-2023-54** and has accepted a bid by the supplier for the supply of those supplies and materials in the sum of **Seven Million Five Hundred Fifty-Four Thousand Six Hundred Thirteen Pesos (PhP7,554,613.00)** only. (hereafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- (i) Invitation to Bid & other Bidding Documents
- (j) Minutes of the Pre-Bid Conference
- (k) Minutes of the Pre-Proc Conference
- (l) Certificate of Funding Chargeability
- (m) Other contract documents that may be required by existing laws and/or the PN.

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.

4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
