

CONTRACT AGREEMENT

THIS AGREEMENT made this _____ day of _____, _____ between CAPT ARCHIBALD DINO C DELFIN PN(MNSA), Commanding Officer, Philippine Navy Procurement Center (hereinafter called "the Entity") and SIX GLAM BUILDERS AND SUPPLY CORPORATION at 2nd Floor, CAP Building, Anda Street, Davao City (Hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute *Infrastructure Projects Supply and Delivery of Labor & Materials for the Repair of PSG Building, NIFEM (INFRA-PNBAC2-2023-13)* and has accepted a Bid for *Two Million Nine Hundred Fourteen Thousand One Hundred Thirty Pesos Only (Php. 2,914,130.00) ONLY*. (Hereafter called "the Contract Price") by the Contractor for the execution and completion of such Works *within One Hundred Forty (140) Days and the remedying of any defects therein*.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs).
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any;
 - b. Winning Bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conform thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution.

4. The Philippine Navy, agrees to pay the above-mentioned sum in accordance with the term of the Bidding.
