PNBAC1 RESOLUTION No. 095-2023

Resolution Declaring ONE COMMERCE INTERNATIONAL CORPORATION as the winning Supplier for the project “Procurement of VSAT Hub for MSACWest” and Recommending Approval of the NOA

WHEREAS, the Philippine Navy Bids and Awards Committee1 conducted procurement of “**Procurement of VSAT Hub for MSACWest**” through “**Direct Contracting**” with an Approved Budget for the Contract of **Eleven Million Six Hundred Eighty Two Thousand Pesos (Php 11,682,000.00)** only;

WHEREAS, the Philippine Navy Bids and Awards Committee1 formally sent a Letter of Invitation to **ONE COMMERCE INTERNATIONAL CORPORATION** on **30 November 2023** relative to the procurement of said project;

WHEREAS, **ONE COMMERCE INTERNATIONAL CORPORATION** submitted a proposal for the project on **060900 December 2023** including its eligibility and technical requirements;

WHEREAS, after perusal of the proponent’s submitted documents, the PNBAC1 found it to be compliant with the eligibility and technical requirements as required by RA 9184 and declared it as “**PASSED**”;

WHEREAS, after a series of negotiations on the provisions of the Contract to be adopted including the price, the PNBAC1 and **ONE COMMERCE INTERNATIONAL CORPORATION** agreed on the stipulations and the amount of **Eleven Million Six Hundred Forty Six Thousand Pesos (Php 11,646,000.00)**.

WHEREAS, upon careful verification, validation and ascertainment of the genuineness and accuracy of the legal, technical and financial documents submitted, the PNBAC1 found **ONE COMMERCE INTERNATIONAL CORPORATION** “**Responsive**” to all the requirements of the Project;

WHEREAS, the Post Qualification Team headed by **CDR EDWARD P CALIMAG PN** conducted post qualification inspection **ONE COMMERCE INTERNATIONAL CORPORATION** on **14 December 2023** at My Sagittarius Place, 609 Block 243 Lot 11 Calderon St., Brgy., Hills Mandaluyong City 1550 and subsequently submitted said inspection report to the Chairman, PNBAC thru the Head Secretariat on **19 December 2023**. After thorough verification, validation and ascertaining all the statements made and documents submitted by the bidder, the Post Qualification Team found and established the bid to be “**Responsive**” to the requirements of the project;

NOW, THEREFORE, for and in consideration of the foregoing, **We**, the **Members of the Philippine Navy Bids and Awards Committee1**, by virtue of the powers vested on **Us** by law, hereby **RESOLVE** as it is hereby **RESOLVED** the following:
