

the CONTRACT AGREEMENT

(304thCO-GS-03-24)

THIS AGREEMENT made this ____ day of _____ between **Philippine Navy, Armed Forces of the Philippines** (hereinafter called "the entity") of the one part and **LSL TRADING, 4816 Valderama St., Pio Del Pilar, Makati City** (herein after called "the Contractor/Supplier") of the other part:

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Supply and Delivery of Students Training Requirements of Various Pre-Entry Courses of SBS and PNOCS (GSPNBAC2-2024-17)** and accepted a Bid by the Supplier for the supply of those goods and services in the sum of **TWO MILLION SIX THOUSAND TWO HUNDRED NINET-FIVE PESOS (PhP 2,006,295.00)** only (herein after called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - i. Philippine Bidding Documents (PBDs)
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted; Bid forms, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents/ statements submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract and the Bidder's conformed thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Procurement of **Supply and Delivery of Students Training Requirements of Various Pre-Entry Courses of SBS and PNOCS (GSPNBAC2-2024-17)** therein in conformity with the provisions of this Contract in all aspects.
4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Procurement **Supply and Delivery of Students Training Requirements of Various Pre-Entry Courses of SBS and PNOCS (GSPNBAC2-2024-17)** and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by the Contract.

IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.
