9. Bid opening shall be conducted via **blended/VTC on June 04, 2024, 09:00 AM, Tuesday at Philippine Navy Bids and Awards Committee, Naval Station Jose Francisco, Fort Bonifacio, Taguig City**. Bidders **may physically attend** the opening and evaluation of bidding documents or through **Video Tele Conferencing (VTC) via Zoom Application. (Zoom Meeting ID: 965 038 3082; Password: SDr9Dz)** who choose to attend the activity. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.
