

**Contract Agreement**  
**(PNPC-PB-SVC-03-004-24-NIF-NCR)**

THIS AGREEMENT made this 16 MAY 2024 between **Philippine Navy, Armed Forces of the Philippines** (hereinafter called "the entity") of the one part and **Doorkeeper Janitorial Supplies and Services B36 L6 PH-II Soldier's Hills-IV Molino, Bacoor Cavite** (Hereinafter called "the Supplier") of the other part:

**WHEREAS**, the Entity invited Bids for certain goods and ancillary services, viz., for the project, **Supply and Delivery of Labor and Materials for Janitorial and Garbage Collection Services of NIF-NCR and MNH** under Project Nr: GS-PNBAC2-2024-12 and has accepted a bid by the supplier for the supply of those supplies and materials in the sum of **Eleven Million One Hundred Five Thousand Five Hundred Thirty-Seven Pesos (PhP11,105,537.00)** only. (hereafter called "the Contract Price").

**NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:**

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.


2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:


- (a) Notice of Award of Contract and the Bidder's conforme thereto;

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.

4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.




