

CONTRACT AGREEMENT
(304thCO-INFRA-09-23)

THIS AGREEMENT made this ____ day of _____ between **Philippine Navy, Armed Forces of the Philippines** (hereinafter called "the entity") of the one part and **SUBICCON CORPORATION, 37 2nd St., West Tapinac, Olongapo City** (herein after called "the Contractor").

WHEREAS, the entity is desirous that the Contractor execute the project **Supply and Delivery of Labor and Materials for the Proposed Asphalt Overlay of NSLG Road nets (Gate 1 to PNOCS) (INFRA-PNBAC2-2023-17)** (herein after called the "Works") and the entity has accepted the Bid for **Ten Million Sixteen Thousand Twenty-Three Pesos and 82/100 Centavos (Php10,016,023.82) Only** within **Forty (40) Calendar Days** under Project PNBAC2 Resolution No. 086-2023 by the Contractor for the execution and completion of such Works and remedying any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:

- a) Philippine Bidding Documents (PBDs);
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of the Contract;
 - v. Supplemental or Bid Bulletins, if any;
- b) Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c) Performance Security;
- d) Notice of Award of Contract and the Bidder's conforme thereto; and
- e) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration of the sum of **Ten Million Sixteen Thousand Twenty-three Pesos and 82/100 Centavos (Php10,016,023.82) Only** or such other sums as may be ascertained, **SUBICCON CORPORATION** agrees to execute and complete the **Supply and Delivery of Labor and Materials for the Proposed Asphalt Overlay of NSLG Road nets (Gate 1 to PNOCS)** in accordance with his/her/its Bid.

4. The Entity agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.
