



**CONTRACT AGREEMENT
(302CO-GSM-019-24)**

THIS AGREEMENT made this 14 MAY 2024 between **Philippine Navy, Armed Forces of the Philippines** (hereinafter called "the Entity") of the one part and **Buennelyn General Mde. of L21 H2 Road L13 Amore Village Brgy Mulawin, Tanza, Cavite** (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Supply and Delivery of 72-100 RF Supplies for PN Units Lot 7-General Supplies** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **SEVEN MILLION THREE HUNDRED TWENTY-THREE THOUSAND SEVEN HUNDRED EIGHTY-NINE PESOS (PhP7,323,789.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
