The BAC shall draw up the short list of consultants from those who have submitted Expression of Interest and eligibility documents, and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”, and its Implementing Rules and Regulations (IRR). The short list shall consist of **maximum of three (3) prospective bidders** who will be entitled to submit bids. The criteria and rating system for short listing are: on Bidding Documents Sec 9.2 Eligibility Data Sheet
7. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184. **Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.**

8. The Procuring Entity shall be evaluated using the Quality-Cost Based Evaluation/Selection (QCBE/S) procedure. The criteria and rating system for the evaluation of bids shall be provided in the Instruction to Bidders.
9. A complete set of Bidding Documents will be provided by PNBAC Secretariat to the short-listed consultants once the Head of Procuring Entity approves the short-list of consultants and upon payment of a non-refundable fee in the amount indicated above at CRB, CPMU, Philippine Navy Finance Center (PNFC), Naval Station Jose Francisco, Fort Bonifacio, Taguig City.
10. Short-listed consultants shall accomplish the Sales of Bidding Document form issued by the PNBAC Secretariat prior payment of the Price of Bidding Documents.
11. The project must be completed within **Three Hundred Sixty-Five (365) calendar days from receipt of NTP up to April 05, 2025** after receipt of the Notice to Proceed, inclusive of mobilization Period.
12. The Philippine Navy reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award, in accordance with Section 41 of RA 9184 and its Revised IRR, without thereby incurring any liability to the affected bidder or bidders.
