PNBAC1 RESOLUTION No. 144-2023

Resolution Declaring HB COMMUNICATIONS TRADING INC. as the Winning Bidder for the project “Procurement and Installation of COMMELEX Equipment for CCPV1 and CCPV2” and Recommending Approval of the NOA

WHEREAS, the Philippine Navy thru the Philippine Navy Bids and Awards Committee1 caused the advertisement of the Invitation to Bid (ITB) for the project “**Procurement and Installation of COMMELEX Equipment for CCPV1 and CCPV2**” at the Philippine Government Electronic Procurement System Website (PhilGEPS) and Philippine Navy Website last 26 November 2023. Likewise, it was posted at conspicuous places within the premises of the PNBAC Office continuously for seven (7) calendar days;

WHEREAS, the PNBAC1 conducted public bidding on 280900 December 2023 through Video Teleconferencing (VTC) wherein one (1) bidder, **HB COMMUNICATIONS TRADING INC.** submitted the required Eligibility, Technical and Financial Proposals of the bid. All documents were found to be compliant and rated “**PASSED**” and subsequently declared as “**eligible**” bidder;

WHEREAS, after a detailed evaluation of the financial proposals submitted by the eligible bidder, **HB COMMUNICATIONS TRADING INC.** the PNBAC1 found the proposals compliant as to form and within the ABC of the project, thus, it was declared the “**Single Calculated Bid**” subject to post qualification, to wit:

WHEREAS, the Post Qualification Team headed by **CDR TED C CEREZO JR PN(GSC)** conducted post qualification inspection **HB COMMUNICATIONS TRADING INC.** on **28 December 2023** at 93 Diego Silang Rd., Phase 1, AFPOVAI, Taguig City and subsequently submitted said inspection report to the Chairman, PNBAC thru the Head Secretariat on **31 December 2023**. After thorough verification, validation and ascertaining all the statements made and documents submitted by the bidder, the Post Qualification Team found and established the bid to be “**Responsive**” to the requirements of the project;
