Bidders **may physically attend** the opening and evaluation of bidding documents or through **Video Tele Conferencing (VTC) via Zoom Application. (Zoom Meeting ID: 965 038 3082; Password: SDr9Dz)** who choose to attend the activity. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.
