(Zoom Meeting ID: 965 038 3082; Password: SDr9Dz)**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before **September 10, 2024, 09:00 AM, Tuesday**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be conducted via **blended/VTC on September 10, 2024, 09:00 AM, Tuesday at Philippine Navy Bids and Awards Committee, Naval Station Jose Francisco, Fort Bonifacio, Taguig City**. Bidders **may physically attend** the opening and evaluation of bidding documents or through **Video Tele Conferencing (VTC) via Zoom Application.
