

**CONTRACT AGREEMENT**

**Supply and Delivery of Labor and Materials for the Construction of NAUW Liaison Office at Naval Station Carlito Cunanan, Bgy. Macarascas, Puerto Princesa City (INFRA-PNBAC2-2024-05)**

THIS AGREEMENT, made this \_\_\_\_\_ day of \_\_\_\_\_, 2024 between **ARMED FORCES OF THE PHILIPPINES (AFP)**, Camp General Emilio Aguinaldo, Quezon City, hereinafter called the "Entity" of the one part through the **Naval Installation Facilities West (NIF-WEST)** as represented by the Flag Officer-In-Command, Philippine Navy, **VADM TORIBIO D ADACI JR PN**; with office address at *Naval Station Jose Andrada, 2335 Roxas Boulevard, Manila* and **ABG CONSTRUCTION** represented by its Authorized Representative, **Mr. John Carmelito Corpuz**, a private organization and existing under the laws of the Republic of the Philippines with business address *Perez Drive, Tumga Zamboanga City* hereinafter called the "Contractor" of the other part;

WHEREAS, the Entity is desirous that the Contractor execute **Supply and Delivery of Labor and Materials for the Construction of NAUW Liaison Office (INFRA-PNBAC2-2024-05)** hereinafter called "the Works" and the Entity has accepted the Bid for *SEVEN MILLION TWO HUNDRED THOUSAND FIVE HUNDRED TWENTY-TWO PESOS (PhP7,200,522.00)* only by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - a. Philippine Bidding Documents (PBDs);
    - i. Drawings/Plans;
    - ii. Specifications
    - iii. Bill of Quantities;
    - iv. General and Special Conditions of Contract;
    - v. Supplemental or Bid Bulletins, if any;
  - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted, including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

  - c. Performance Security;
  - d. Notice of Award of Contract and the Bidder's conforme thereto; and
  - e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**




