

Contract Agreement
(302CO-SERV-149-24)

THIS AGREEMENT, made this _____ between Philippine Navy Armed Forces of the Philippines (hereinafter called the "Entity") of the one part and Herma Shipyard Inc. of Herma Industrial Complex Mariveles Bataan (Herein after called the "Contractor") of the other part:

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz., for the project of **Drydocking and Other Related Repairs (DDORR)** of **BRP ANG PANGULO (ACS25)** and has accepted a Bid by the supplier for the supply of those goods and services in the sum amount of **ONE HUNDRED SIX MILLION FOUR HUNDRED NINETY-FIVE THOUSAND PESOS ONLY (Php106,495,000.00)** (hereinafter called "the Contract Price")

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby Covenants with the Entity to execute and complete the Works and Remedy any defects therein in conformity with the provision of this Contract in all respects.
4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this contract.
