

Contract Agreement
(302CO-SERV-072-24)

THIS AGREEMENT, made this MAY 20 2024, between Philippine Navy, Armed Forces of the Philippines (hereinafter called the "Entity") of the one part and Pacificfortia Marine Technologies Inc. (Hereinafter called the "Contractor") of the other part:

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz., for the project of **Beaching and Other Related Repairs (BORR)** of 7MTR RIB04, 7MTR RIB05 & 7MTR RIB06 and has accepted a Bid by the supplier for the supply of those goods and services in the sum amount of **TWENTY-FIVE MILLION THREE HUNDRED EIGHTY-FIVE THOUSAND SIX HUNDRED THIRTY-EIGHT PESOS ONLY (Php25,385,638.00)** (hereinafter called "the Contract Price")

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, viz.:


- (a) Schedule of Requirements
- (b) Technical Specifications
- (c) General Conditions of Contract
- (d) Special Conditions of Contract
- (e) Notice of Award (NOA)


3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby Covenants with the Entity to execute and complete the Works and Remedy any defects therein in conformity with the provision of this Contract in all respects.

4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this contract.




