**CONTRACT AGREEMENT  
(302CO-GSM-071-24)**

THIS AGREEMENT made this \_\_\_\_\_ between Philippine Navy, Armed Forces of the Philippines (hereinafter called "the Entity") of the one part and Anwelh Holdings Incorporated of 198 A. Mabini Street., Maypajo Brgy. 032 Dist. 2 Caloocan City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly Procurement of Ground Support Equipment for the Enhancement of NAW Aerodrome Operations Capabilities and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of EIGHTY-SEVEN MILLION EIGHT HUNDRED SIXTY-SIX THOUSAND FOUR HUNDRED THIRTY PESOS (PhP87,866,430.00) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:


- i. Philippine Bidding Documents (PBDs);

- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of EIGHTY-SEVEN MILLION EIGHT HUNDRED SIXTY-SIX THOUSAND FOUR HUNDRED THIRTY PESOS (Php87,866,430.00) or such other sums as may be ascertained, Anwelh Holdings Incorporated agrees to Procurement of Ground Support Equipment for the Enhancement of NAW Aerodrome Operations Capabilities in accordance with his/her/its Bid.
4. The Philippine Navy, Armed Forces of the Philippines agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
