



**CONTRACT AGREEMENT
(302CO-GSM-074-24)**

THIS AGREEMENT made this _____ between Philippine Navy, Armed Forces of the Philippines (hereinafter called "the Entity") of the one part and Aces Marine And Links Industrial Corporation of 17A Aces Bldg, Manuela Ave. Doña Manuela Subd. Las Piñas (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly Supply and Delivery of Materials/Parts for the PMS/COBS of MTU of CYCC2 and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of SIX MILLION NINE HUNDRED FORTY-SEVEN THOUSAND ONE HUNDRED EIGHTY-EIGHT PESOS (Php6,947,188.00) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
