

**CONTRACT AGREEMENT  
(302CO-GSM-091-24)**

THIS AGREEMENT made this \_\_\_\_\_ between Philippine Navy, Armed Forces of the Philippines (hereinafter called "the Entity") of the one part and Aces Marine And Links Industrial Corporation of 17A Aces Bldg, Manuela Ave, Doña Manuela Subd. Las Piñas (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly Supply and Delivery of Materials/Parts for the PMS/COBS of Various PHILFLEET Vessels: MTU Engines of FAIC Vessels and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of SEVENTY-NINE MILLION EIGHT HUNDRED SEVENTY-NINE THOUSAND EIGHT HUNDRED EIGHTY-EIGHT PESOS (PhP79,879,888.00) (hereinafter called "the Contract Price").

**NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:**

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
