

**CONTRACT AGREEMENT  
(302CO-GSM-059-24)**

THIS AGREEMENT made this 12-3-1111-2021 between Philippine Navy, Armed Forces of the Philippines (hereinafter called "the Entity") of the one part and Stellarsat Solutions Inc. of 2<sup>nd</sup> Flr Unit 7, 24K, Mansion Bldg, Sct Tuason St. Dillman, Quezon City 1103 Metro Manila (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Subscription of Social Media Analytics Tool Project** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **ONE MILLION TWO HUNDRED FIFTY THOUSAND PESOS (Php1,250,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;


Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;

4. The **Philippine Navy, Armed Forces of the Philippines** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


