WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly Procurement of Vehicle for NAW Aerodrome Operations Capability and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of THIRTY-NINE MILLION NINE HUNDRED EIGHTY-NINE THOUSAND PESOS (PHP39,989,000.00) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

4. The Philippine Navy, Armed Forces of the Philippines agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


